The Limits to Union: Same-Sex Marriage and the Politics of Civil Rights. 2002. University of Michigan Press. Revised and printed in paperback, 2004.

This book s the same-sex marriage controversy and its meaning for legal mobilization and social change. Two political discourses are shown to modulate this controversy: the first is a new articulation of political sovereignty which has been deployed to rewrite lines of authority to exclude courts and the claims of gay and lesbian rights activists. The second is a post-Fordist discourse of political economy that has altered the meanings of contract. Between the discourses of sovereignty and of political economy, both of which valorize some aspects of law and rights while repudiating others, this book argues that a new American governmentality is emerging. This book characterizes this new form of rule—and this changing mentality—by analyzing these discursive struggles in the marriage issue, their performative consequences, and the politics of those groups and individuals most involved. It thus seeks to transcend and re-envision the moral terms of this values debate by tracing how discourse about rights transforms political authority.
